Cymar AGM 24/1 Opening Worship

QF&P 10.04 was read to us during opening worship

Cymar AGM 24/2 Friends Attending

At the start of our meeting today there are 67 Friends attending, 51 in person in Hereford and 16 online. Each of the constituent bodies of Cymar has at least two representatives present

Cymar AGM 24/3 Elders for the meeting

We appoint Colin Brown (SMAQM) and Ann Harris (NWAM) as elders in Hereford and Sue Shreeve (MWAM) as elder online

Cymar AGM 24/4 Trustees Annual Report

We have received the trustees' Annual Report for 2024. Jeremy Brignell-Thorp introduced the report; Tricia Bridgwater spoke to the finance section. Trustees will ensure that final financial forms are provided in both Welsh and English in future. It was clarified that legal fees had largely been covered by BYM. Transfer of assets is expected to be complete by the end of 2024.

Erica Thomas has updated us on the property issues; and on safeguarding.

We thank our trustees for the enormous amount of work that has brought us to this point. We also join the trustees in thanking all those involved in the preliminary work to form Cymar. We hope that the path ahead will not be too rock-strewn, and that the transfer of the existing charities progresses smoothly. We hold trustees in the Light as they take these final steps.

Trustees have brought forward the date of 20 September 2025 for the next AGM, with the venue yet to be discerned. We agree to this date.

# Cymar AGM 24/11 Paul Parker, Recording Clerk of Britain Yearly Meeting addressed the meeting on The Future of Quakerism.

He described Cymar as trail-blazing, developing a new way of working for Quakerism. We are being carefully observed by other regions of the UK.

He posed the question "Do Quakers want to survive or do we want to thrive?" Not declining in numbers is not the same as thriving. The world beyond Quakerism is also changing and may move towards a more caring and sharing society, or its opposite. But one thing we can say with certainty is that in thirty years' time there will be many people who want to come together to feel connected in a spiritual way, and Quakers can be part of this. We can provide a space where people can feel connected, both with God and each other.

We need to get around our aversion to outreach. And we need to find new language about who and what we are. We also need to tackle our lack of diversity. We are incomplete without those who need to be with us. Most people currently going to Quaker meetings first came along because someone took them to a Meeting for Worship. All it would take to reverse our decline in numbers is for one new person to join each local meeting each year. The people that could bring them along are us.

We are already seeing the green shoots of how we can do things differently, and Cymar is one of these shoots. Others include the laying down of Meeting for Sufferings, bringing us all closer in a continuing Yearly Meeting; new online meetings; Meetings for Worship in new times and places; a new Book of Discipline under preparation.

There are many ways that the future of Quakerism is positive, but we have to be prepared to change so that we are welcoming to the people that need us.

#### Cymar AGM 24/12 Worship Sharing and Final Minute

Today we came together from five different Quaker groupings. We go forward as a new organisation, with the hope that each of our Area Meetings and CCQW will find fresh energy and the means to thrive. Our new trustees are taking a burden off our shoulders, and we step out on a new path.
